After the initial distribution, applications will be accepted until the FINAL application submission deadline of September 29th, 2017. After which, the FINAL gift card distribution will be available October 13th, 2017. If you cannot pick up the gift card by the deadline, LIBC must receive a request for it to be mailed to you by October 13th, 2017. Documentation of Enrollment and Custody of the above named child may be required with this application. If a card is obtained illegally the card will be reported stolen to Lummi Law & Order and/or other Law Enforcement agencies and criminal charges may be initiated against persons who illegally claimed cards for children who are not legally in their custody. Please pay attention to the optional pick up person, this will be strictly adhered to. If a family member is not listed in the optional pick up the card will not be released to them.

Declaration of Eligibility & Permission to Release information
